

Morgan County Caring for Kids Coalition—4th Annual Hope Ray Dunklee Memorial Run/Walk

Saturday, March 25, 2017

The 5K Competitive run will begin at 9:00 am on an asphalt surface with gentle rolls starting at the Versailles High School, going north on Highway 5 before turning northwest, then returning via the same route to the starting point. The 2-mile casual walk will begin at 9:15 am on an asphalt surface. The Half-Mile Kids Run (ages 10 and under) will begin at 10:15 am and will take place on the high school track. NO roller blades or wheeled shoes, please. Parking, changing rooms, and restrooms are available at the Versailles High School.

AWARDS: An overall award will be presented to the first male and female finisher in the 5K run. A medal will be given to first place in each age division in the competitive race. All participants in the 1/2-mile kids run will receive a participation medal.

Award winners must be present to receive their award.

Age divisions for Male and Female are:

5K Run and 2-Mile Walk - 14 years and younger, 15 to 19 years, 20 to 29 years, 30 to 39 years, 40 to 49 years, 50 to 59 years, and 60 years and older.

REGISTRATION: Must register by March 10th to receive a 2017 T-shirt (NEW DESIGN THIS YEAR!!). *Any pre-registered participants not walking or running on race day must make arrangements by Wednesday March 22, 2017 to pick up their shirts or forfeit them.* All registrations not received by March 10th are not guaranteed a current 2017 NEW DESIGN T-shirt or size choice. Entry fee is \$25 for all events, except Half-Mile Kids Run which is \$10. Late entry fee (after March 10th) is \$30 for all events. All proceeds support Morgan County Caring for Kids Coalition – Back to School Health Fair.



PACKET PICK-UP: Early pick-up from 4:00 pm to 7:00 pm day before event. Packet Pick-up and late registration day of race 7:30 am to 8:30 am. Kids Run packet pick-up from 9:00 am to 10:00 am on race day only. All pick-ups will be at Versailles High School Commons.
